

#### **Broad Term & Conditions**

- 1) The team assigned for the school audit work must have the relevant experience indicated in the profile/s and the bid documents. The statutory audit work needs to be completed well before the applicable due date, provided the school keeps the required records ready and informs the statutory auditors accordingly.
- 2) School will provide Accommodation and Food facilities during the period of the audit work at the school site / location. No other out of pocket expense would be reimbursed by the school. Taxes, duties etc. as required under the applicable laws would be withheld (TDS) from the amount payable for the subject work.
- 3) The school location can be reached by road and/or rail with nearest major railway station being Nandurbar, in Maharashtra.
- 4) The bid / quote for Fees, exclusive of GST, should not be less than Rs. 20,000/- and should be valid till February 28, 2025.
- 5) The appointment may be renewed for subsequent year/s at mutually convenient terms and conditions after the successful completion of the audit work for FY25.
- 6) School expects broad guidance and views, when sought from auditors on accounting and other relevant matters of statutory importance and compliance in relation to audit work.
- 7) Selection of the final bid will, *inter alia*, be based on the nature and scale of experience of the bidder and may not be solely based on the basis of the lowest fee quote. Before the final decision is taken, the school management may choose to interact with the representative of select bidders found relevant, for gathering more insight. The decision of the school management will be final and binding on all the stakeholders, without any right to protest and/or challenge. The school will communicate the decision to the selected/ winning bidder by email.
- 8) At all the time, the School management reserves the exclusive right to modify/waive any terms and conditions of this Tender or the Tender *per se*.
